What is a Contract?

- An agreement between two or more parties to do or not do something.
- Required elements are offer, consideration, acceptance, mutuality.
- > A peppercorn as consideration.



Do contracts have to be in writing?

- As a general rule, no, oral contracts can be enforced.
- But the following generally must be in writing:
 - Agreements regarding sale of real estate or more than \$500 in goods;
 - Promises to make a loan or pay another's debt; and
 - Promise that cannot be performed within one year.
- Estoppel Issues
- Invoices as contracts



Remedies for Breach



-or-

An order that the promised be fulfilled, the contract performed.



What to do if you perceive a breach?

- Be polite but firm
- Avoid waiver/estoppel arguments
- The "Mutual Departure" doctrine in Georgia
- Save your records
- Consult an attorney!



What if you are accused of breaching a contract?

- Consult an attorney!
- Retain your records
- Respond to allegations/Silence as acquiescence
- A stitch in time....



Specific Contract Issues

- Employment issues:
 - Good to put benefits in writing
 - Good to specify employment status (at-will employment).



Other Specific Contract Issues

Purchase Orders and Invoices:

- Look at the small print

Policy or standards manuals:

- Clarify who owns the work.



Some General "Do's":

- ✓ Know who you are doing business with
- ✓ Make sure the party names are accurate
- ✓ Read the agreement in full
- ✓ Be sure you understand all terms
- ✓ Use plain English and definite terms
- ✓ Be sure terms of art/industry terms are defined
- Consider requiring a notice and cure provision and a negotiation provision
- ✓ Consider limitations of liability and requiring insurance



Some General 'Don'ts'

✓ Don't agree to ambiguous language

- Don't accept other side's interpretation of unclear terms
- ✓ Don't have redundant terms or provisions

 Don't sign agreement with blank terms or missing parts
