# **Does Your Nonprofit Need a Business License?**

Many counties and cities require nonprofit organizations to register for a business license, also referred to as a Business Occupational Tax Certificate. Nonprofits should consult their local government to make sure that they are in compliance with all the appropriate requirements. Organizations that do not have a valid and current business license when one is required could be subject to citations, penalties, and fines.

# General tips

- Check with the local government of each county and city where you have a business location or conduct business, even if you are not sure whether your activities in that area trigger the need for a business license.
- Register with the county if you are located or conducting business outside of the limits of an incorporated city. Otherwise, register with the city.
- Always include your 501(c)(3) status letter with any application for a business license; make sure to tell the person handling your case that you are a nonprofit organization.
- Nonprofits may be exempted from paying occupation taxes, so you should discuss any possible exemptions with the local government issuing each of your business licenses well before taxes are due.
- Most local governments require you to renew your business license every year.
- · Make note of upcoming deadlines.
- Review the information below about some of the counties and cities located in the Metro Atlanta area.

## **Cities**

### City of Atlanta

- Register using the City of Atlanta's online portal, "ATLCORE". There is a \$75
  registration fee, but nonprofits do not have to pay the \$50 zoning fee. Please use
  Chrome to access the portal as other internet services will not function properly
  with ATLCORE.
- To renew the license, use the same ATLCORE online portal.

 Register with the City Clerk. There is no application fee for nonprofits. In the application, mark nonprofit as your gross receipts.

- Register with the Department of Planning and Sustainability.
- Applications will be reviewed by the Zoning Department prior to issuance of a BOTC. There are no fees for the application with proof of nonprofit status.

# **Fulton County**

- A business license is required for nonprofits with 501(c)(3) status and you
  must apply by visiting the Business Occupational Tax Division Office in the
  Fulton County Government Building.
- Take your 501(c)(3) letter from the IRS with you to the Business Occupational Tax Division Office and fill out an application.
