

Dear Friends and Supporters,

In 2022, Pro Bono Partnership of Atlanta (PBPA) continued to strengthen community nonprofits with free legal assistance. With the help of 811 legal volunteers, PBPA served almost 300 nonprofit clients, who in turn impacted the lives of millions of individuals in the Greater Atlanta area. Those individuals include refugees, veterans, survivors of domestic violence, and families experiencing homelessness and food insecurity.



A particular highlight from this past year was the launch of our newest program, the Black-led Nonprofit Legal Bootcamp, in May 2022 with six emerging nonprofit organizations participating in the first cohort.

(A second cohort of 13 organizations began in January 2023). Participants receive tailored legal education, opportunities to connect and share experiences with other nonprofit leaders, and assistance in developing a capacity-building action plan for their organization. Guest speakers included Georgia Power's Bentina Terry who shared her perspective as a serial nonprofit board member and provided invaluable advice to the 13 nonprofit leaders.

CLIENT SPOTLIGHT: Project Community Connections, Inc. (PCCI)

Project Community Connections, Inc. (PCCI) reached out to Pro Bono Partnership of Atlanta (PBPA) in 2018 for assistance with the possible acquisition of property. PCCI, a nonprofit dedicated to permanently rehousing individuals and families experiencing homelessness, had a vision of developing their downtown property into a mixed-income, mixed-use community. The first step in fulfilling that vision was to secure a parcel of land (underneath and around the iconic Coca-Cola sign) next to PCCI's property. PBPA matched PCCI with volunteer attorney Alison Boyer of Miller & Martin, who also volunteered to help review partnership agreements for PCCI. Following the closing on the property a couple of years later, PCCI Co-CEO Margaret Schuelke thanked Alison for the "critical role that Alison play[ed] in this work. She is a consummate professional and a thoughtful and generous human being."

As PCCI moved forward with their vision, they reached out to PBPA for more assistance with drafting a condominium declaration for the new development. PCCI would maintain its office space on the new property and add additional space for mission-aligned nonprofits, while the rest of the property would include affordable and permanent supportive housing in partnership with Mercy Housing Southeast. David Stewart of Adams and Reese volunteered and as he worked with PCCI, he offered to assist with more aspects of the deal,



including helping to close on a construction loan. At the time of loan closing, Margaret shared, "Over the past year, David has dedicated countless hours on this project, regularly expanded the scope of his work without question or hesitation and with patience and expertise provided expert legal advice to PCCI. It is hard to convey in words how much comfort he's brought to [PCCI Co-CEO] Jimiyu Evans and myself – not to mention our Board of Directors – during these very stressful and exhausting months." PCCI again asked PBPA for help when they needed tax advice regarding the legal structure for the services and business centers on the ground floor of the facility. Mary Benton of Alston & Bird raised her hand and continues to provide critical legal advice to PCCI.

PCCI's "wishful concept in our zeal to help end the cycle of poverty and to provide quality affordable housing to individuals and families in need" recently came to reality when they celebrated the grand opening of Thrive Sweet Auburn. The multi-use community center will provide an array of resources and services to area residents including 117 affordable apartment homes for individuals and families (including veterans), a medical clinic, services for job seekers, a coffee shop and more. Located in Atlanta's Old Fourth Ward neighborhood, Thrive Sweet Auburn was recognized by the Atlanta Business Chronicle as Best in Atlanta Real Estate in the residential real estate deals category. According to Margaret, "PBPA and volunteers like David, Alison and Mary helped us turn our vision into reality. They believed in the idea and believed in us."
