Pro Bono Partnership of Atlanta continued to serve our nonprofit community throughout 2023, supporting hundreds of organizations with thousands of hours of free legal services. These organizations, in turn, support residents across Georgia with critical programs and services. Our nonprofit clients span a wide variety of service areas – from refugee assistance, to food security, to youth education, to healthcare for the uninsured.

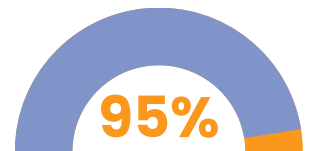

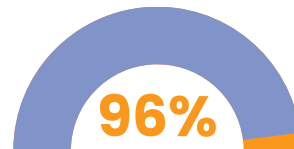

# CLIENT SPOTLIGHT

## Partners for HOME Addresses Homelessness in Atlanta

Finding low-cost housing options for people experiencing homelessness is a challenge in the Atlanta community. Many nonprofits help people find rapid and affordable housing, and Pro Bono Partnership of Atlanta (PBPA) is assisting them with legal matters related to this important work.

In January, 40 unhoused people moved into The Melody, a new access-controlled housing complex on public land in downtown Atlanta featuring permanent housing in shipping containers. PBPA supported this effort by providing legal assistance to Partners for HOME (PFH), the lead agency through which the City of Atlanta coordinates its efforts to end homelessness.

The studio units at The Melody each have a bed, bathroom, and kitchenette. Conceived of and then opened in just four months, the complex offers a state-of-the-art camera security system, supportive services, personal case management, laundry facilities, and a dog park. It is named for Melody Bloodworth, a woman who was unhoused with behavioral health challenges and died on Atlanta's streets in November 2022. PFH owns the shipping containers and leases the land from the City of Atlanta.

Established in 2015 (with help from PBPA), PFH is focused on ending homelessness in the City of Atlanta. It creates and executes the strategy to do that by serving as the Collaborative Applicant for the Atlanta Continuum of Care – a HUD program that promotes community-wide commitment to the goal of ending homelessness. PFH works with the City of Atlanta's Mayor's office and state and private organizations to leverage and align funding and vouchers for housing interventions and solutions.



In 2021, PFH participated in a PBPA Nonprofit Legal Check Up to identify the organization's legal needs. Since then, PBPA has assisted in more than 20 other matters including revising bylaws, standardizing contracts, developing employee and volunteer handbooks, and establishing social media protocols.

"PBPA ensured we are legally sound and shored up how we operate," said Cathryn Vassell, Chief Executive Officer of PFH. "That helps us do our job more easily and sets the pipeline of funds for rapid housing initiatives like The Melody up for success. The caliber of lawyers PBPA brings to the table is always great, and we are incredibly grateful."

Michael Tippet, a PBPA volunteer real estate attorney with Carlton Fields, reviewed the land lease for The Melody, advising PFH on needed amendments. Alex Strang, a PBPA volunteer finance attorney with Polsinelli, set up a special purpose entity for The Melody to mitigate risk for PFH. Now, other PBPA volunteer attorneys are establishing the ownership governance structure.

Jack Hardin, a Partner with Smith, Gambrell & Russell, is on the PFH Board of Directors and assists other PBPA clients who work to provide affordable housing. "The Pro Bono Partnership is a lifeline to the nonprofit community of Atlanta," he said. "The contributions of volunteers to the innovative Melody project were critical, but just one example of mission critical PBPA assistance to nonprofits with which I have been privileged to be affiliated. PBPA is a gift to the Atlanta community."

PBPA is proud to provide free legal assistance to PFH and about 30 other nonprofits addressing homelessness and providing low-cost housing in the Atlanta area, including 3Keys, Star C Corporation, Open Doors Solutions, and Intown Collaborative Ministries.
