Strengthening Advocacy for Children: PBPA and the CASA Network

Court Appointed Special Advocates (CASA) organizations play a critical role in ensuring that children in foster care have a voice in court. These nonprofits recruit, train, and support volunteers who advocate for the best interests of children who have experienced abuse or neglect. Through their work, CASA volunteers help judges make informed decisions that lead to safe, permanent homes for children across Georgia.

Pro Bono Partnership of Atlanta (PBPA) acts as legal counsel to many CASA organizations in Georgia, providing guidance to strengthen their operations and protect their missions. In 2024, PBPA supported 13 CASA organizations, helping them navigate legal matters so they can focus on their mission. From employment practices and governance to volunteer agreements and privacy policies, PBPA helps CASA organizations strengthen their foundations and reduce legal risk.
